Your responsibilities as a student member

- Reading documents and extracting relevant information from committee papers.
- Attending committee meetings.
- Providing a student perspective on issues raised at committee meetings.
- Contributing to committee discussion and to the production of committee papers.
- Participating in Student Voice Group (SVG) meetings, and inputting to meeting agenda setting where appropriate.
- Sharing your experience of being a student member through writing posts for the University's Official Student Blog, social media, and other channels (optional).

Required skills for student membership

In your application, you will be required to give an example to demonstrate competence in three areas. You will be invited to write no more than 100 words about each competency.

Intellectual Skills

- •Analyses and synthesises committee papers effectively
- •Thinks critically to identify issues relevant to the student experience
- Has an inquiring mind, considers 'outside the box' possibilities

Personal Qualities

- Adopts an enthusiastic approach, sustained throughout appointment
- Manages time well, balancing committee meeting preparation and attendance around academic studies
- •Seeks guidance when required

Professional Conduct

- •Has a sense of collegiality, works well in a team
- Good interpersonal communication skills, including self-expression and listening skills
- Understands the confidentiality of committee business
- •Strong commitment to the University community

Eligibility

- You must be a student with us during your appointment;
- You must have completed and passed one cycle of final assessment with the University (if you haven't received your results yet, you would still be welcome to apply);
- You must be able to attend meetings in London on the dates specified in this application pack. Your travel
 expenses to attend meetings will be covered by the University. As such, we welcome applications from
 students who are able to travel to meetings in London in a convenient and cost-effective way. Typically, this
 applies to students in the UK and other parts of western Europe.

Application and appointment process

- 1. Read the information in this document about our committees and the Student Voice Group, as well as eligibility criteria and general responsibilities for student membership.
- 2. Check you are available on the dates listed for the committee(s) you are applying to join.
- 3. <u>Apply online</u>. Make sure you give examples of how your experience matches the YouEngage skill blocks for student membership and tell us about any other experience you think is relevant.
- 4. The application deadline is 9.00am GMT+1 on Thursday 23 August 2018.
- 5. We will acknowledge receipt of your application after the deadline has passed.
- 6. We will contact you by Monday 3 September 2018 to let you know whether you have been appointed as a student member. If we are not able to appoint you onto a committee this year, you will be given the option to be contacted to provide feedback on University projects when the need arises.

Shortlisted applications will be reviewed by a nominations panel that will make recommendations for nomination to the Chair of the University of London Worldwide's Academic Committee.

Appointments are for a period of one academic year, extendable up to a maximum of two years following an evaluation by the Pro-Vice Chancellor (International) of the University of London.
