# Programme overview

#### **Programme duration**



Our Masters degrees and Postgraduate Diplomas can be completed in a minimum of two years and a maximum of five years. Postgraduate certificate students have a

minimum of one and maximum of five years.

#### Module length

#### Entry requirements

#### Master of Science (MSc)/Postgraduate Diploma

Direct registration for an MSc requires you to have an undergraduate qualification, as recognised by the University of London, with good grades in a relevant subject area.

Relevant professional experience will be taken into consideration when assessing application.

#### Individual Professional Award (IPA)

Applications are assessed on their merit and at the discretion of the centre. This may offer some experienced and able candidates without a first degree a route into postgraduate training.

#### **English Language Competency**

You will be required to have a high level of English language ability in reading and writing, and in study skills. If your first degree was not taught in English, you will need to provide evidence of language ability as tested by the British Council or another registered body. We require the International English Language Testing System (IELTS) score of 7.0, with no less than 7.0 in each of the writing and reading tests.

#### MSc/PGDip/PGCert Agricultural Economics

#### Convenor: Professor Bhavani Shankar

This programme provides students with the essential tools required for theoretical and empirical economic analysis, particularly in relation to the agri-foodsector. It aims to equip students with the rigorous technical skills that are generic to the field of agricultural and food economics, while maintaining a focus on applications rather than abstract analysis. Students are able to take modules orientated towards development, production, marketing, policy, and economic transition. The programme is designed for those who wish to pursue a career as an agricultural economist or to undertake higher studies within this area.

MSc students take four core modules, three elective modules and two research modules, one of which is a dissertation.

PGDip students take four core modules and four elective modules; including one free choice from across all programmes.

Environmental issues at local, national and global levels are among the foremost challenges facing society today. It is widely recognised that most environmental problems, whether small-scale or global, are the result of a complex interaction of natural processes with economic forces and decisions. This programme provides graduates with a sound theoretical base and practical appreciation of the concepts and methods of environmental and natural resource economics relevant to policy decisions and research. It is designed to suit students with a primary interest in issues and policies concerning the rural environment.

The MSc Global Energy and Climate Policy is the online version of the successful campus degree of the same name. It provides students with a detailed understanding of the transformative change in energy systems now under way around the world and equips them with the knowledge and skills needed to play a part in it. It treats energy and climate change policy as inextricably linked, taking an integrated approach to the study of the two fields. Case studies are drawn from around the world, accounting for different conditions in developed, newly-industrialised and developing country contexts.

The MSc's focus is on policy and policymaking in the energy and climate space as the key to enabling change and creating the requisite legal and regulatory environment within which the low-carbon energy system of the future can develop and grow. - the ability to demonstrate a critical understanding of the nature and development of global diplomacy, drawing on a variety of relevant contributing disciplines in the broad field of International Studies.
- an understanding of changes in diplomatic practices and procedures and the relationship of those changes to contemporary politics.
- a sound grounding in both theoretical and empirical approaches to debates in diplomacy, so that students have been exposed to the skills needed to analyse global diplomacy.
- knowledge of issues in global diplomacy in historical and contemporary contexts.

#### **Understanding Research Methods**

Taught by: Dr J. Simon Rofe, Dr Yenn Lee

Duration: 4 weeks

This MOOC is about demystifying research and research methods. It will outline the fundamentals of doing research, aimed primarily, but not exclusively, at the postgraduate level. It places the student experience at the centre of our endeavours by engaging learners in a range of robust and challenging discussions and exercises befitting SOAS University of London's status as a research-intensive university and its rich research heritage.

The course will appeal individuals who require an understanding of research approaches and skills, and importantly an ability to deploy them in your studies or in your professional lives. In particular, this course will aid individuals who have to conduct research as part of their postgraduate studies but do not perhaps have access to research methods courses, or for those who would like additional support for self-improvement. No prior knowledge or experience in research is required to take this course and as such, the course is suitable for all.

#### Global Diplomacy: The United Nations in the World

The Global Diplomacy: The United Nations in the World MOOC will offer a well-researched and broad-ranging primer to the United Nations system, providing students with an introduction to the complex UN family and its history, and a series of 'snapshots' of key UN functions.

Through the exploration of these important UN themes, learners will develop important analysis, communication, and policy-based skills.

#### Global Energy and Climate Policy

Taught by: Dr Harald Heubaum

Duration: 6 weeks

As energy markets go truly global, domestic energy policies are becoming more and more entangled with wider issues of international governance. In this MOOC students will explore the changing role of fossil fuels, nuclear power, renewables, climate and energy governance, energy security, as well as the Paris Agreement on Climate Change and its implications for both international and domestic action. Students will gain a theoretical and practical understanding of how energy and climate change policies are designed, shaped, advocated and implemented.
