It means you are considered to have completed the course/s for the purposes of progression within the programme. Credit is awarded but the mark obtained for a qualification recognised and accredited by us will not be carried forward to your record and will not contribute towards the award.

The University reserves the right not to consider an application for recognition of prior learning if the qualification of the respective professional body or institution changes after the publication of this list.
