The minimum period of registration for this programme is 1.5 years. In order to complete in this time, you should study two 15-credit modules per 10 week session and plan the order in which you will need to take the modules based on module availability and the table below. You will need to register for your modules ahead of each 10 week session by the registration deadline specified.

Specific examples are provided below.

Although resits will not necessarily affect the time in which you can complete your programme of study, taking less than 30 credits per session will extend your minimum period of registration. For instance, only studying one 15 credit module for one or two sessions will increase your study time by one session or more (dependent upon module availability); only studying one 15 credit module for three or four sessions will increase your study time by at least 6 months.

Remember that you must have passed 60 credits before you register for the Capstone Project
