## INTRODUCTION

This catalogue was compiled at the Headquarters of the Family Welfare Association, Vauxhall Bridge Road, S.W.l., in 1962, before the transfer of the Association's Library to the University of London Library, Senate House, W.C.l., the following year.

It is an alphabetical author list of the bulk of the Library as it then was. The few items in this list marked FWA in the right hand margin were in fact retained by the Association. Similarly those marked NI were transferred to the National Institute for Social Work Training. (The addition of a number to these marks denotes the number of copies the Association or the Institute has, when there was more than one copy originally. Any remaining copies are in the possession of the University.) Apart from items so marked, all the material in this list is now housed in the University of London Library where it has been deposited by the Association on permanent loan.

The list does not include about three hundred volumes of bound pamphlets and a hundred volumes of collected government reports and papers, which were not catalogued, but are now also in the University Library. Neither does this list contain what may be termed the 'Archive' material of the Library. This too has been retained by the Association. It consists mainly of the following: the minutes, agenda and other confidential material of the Council of the Association and its committees; the annual reports of the Council and the District Committees; the periodical publications of the Association, i.e. Charity Organisation Reporter, Charity Organisation Review, Charity Organisation Quarterly, Social Work, the Annual Charities Register and Digest and the Guide to the Social Services; the Association's series of publications, such as Occasional Papers and Charity Organisation Papers. There are however some publications of the Society among the books transferred to the University Library and these will be found in the following list under the name of the Association.
